#### **CONDITIONS:**

- 1. Salaries are to be paid by cheque to the individual teacher account only.
- 2. Five journals should be subscribed
- 3. Books worth of Rs 30,000/- which are in the syllabus (reference books) have to be procured.
- 4. College website has to be updated and the photographs including the details of Principal and all the teachers working in the college are to be uploaded to the college and University website.
- 5. Teaching diaries and student attendance registers are to be maintained properly.
- 6. Three Governing Body meetings are to be conducted in an academic year associating University nominee and the resolutions are to be submitted through University nominee only.

The Management is directed to submit the compliance Report on the fulfillment of the above conditions within one week with documentary evidence wherever necessary, through Governing Body member nominated by the University in the following prescribed proforma.

## GENERAL CONDITIONS TO BE FULFILLED BY ALL COLLEGES:

- 1. That they should appoint teaching staff through duly constituted selection committee as per NCTE 2014 norms, associating the University Nominee on the Selection Committee and Subject Expert representing all Methodologies and obtain the Renewal/Approval from the Registrar MGU for the Existing / New staff at the beginning of the academic year whenever
- 2. As per NCTE norms the Management has to shift the College to its own premises within (3) academic years from the date of establishment.
- 3. To provide spacious rooms for classes and laboratories and separate toilets for boys and girls as suggested by the InspectionCommittee.
- 4. Consolidated attendance statement is to be prepared every year and submit to the
- 5. It is made clear to your college that if the above conditions are not fulfilled by your college within the stipulated time, your college will be disaffiliated under intimation to NCTE/State Government.
- 6. To appoint a qualified librarian
- 7. Attendance registers and teaching diaries are to be maintained properly. Attendance to be marked in the class room only.
- 8. College should follow MGU almanac strictly.
